WHEREAS, the place teem with people coming from all parts of the country and other tourist from foreign countries, who are so awed with its natural beauty that the Municipal Government took charge of its activities by manning the area with employees who will oversee and collects whatever fees and dues derivable thereat;

WHEREAS, the revenues raised at the Hinulugang Taktak is included in the General Fund of the Municipality, but also expended for salaries and maintenance of personnel and other services that there is need for the creation of a body or agency to run the affairs of Hinulugang Taktak independently, but still under the powers and authority of the Municipal government through the Municipal Mayor;


NOW THEREFORE, on joint motion of Coun. Emilio B. Flores and Coun. Celestino M. Gatlabayan duly seconded by Coun. Ernesto de Jesus, it resolve as it is hereby resolved that a body or an agency be created by the Municipal Mayor under and by virtue of the powers and authority vested in him by the Provisions of Sec. 141, Article 1, Chapter 3, Title II of the Local Government Code and to do whatever is necessary in carrying out the purpose and objectives of this resolution.

RESOLVED FURTHER that copies of this resolution be furnished to government agencies concerned, A-FACE, INC. and other environment and tourism-oriented organizations for their information and reference.
