RESOLUTION NO. 87-006

WHEREAS, the Municipality of Antipolo was pronounced by the Supreme Court in the case entitled "Municipality of Antipolo vs. Aquilino Zapanta, et al" as the possessor rightfully entitled to the use and permitted to use as within the prerogatives and purposes of a Municipal Corporation;

WHEREAS, The same Supreme Court declared the area (now the market lot) as public land; and therefore is open for disposition for title with Municipality of Antipolo having all the priority and preference to acquire the same;

WHEREAS, said property (land) should have long been Titled in the name of the Municipality, where it not for the omission and negligence of former officials of this town;

NOW THEREFORE, on joint motion of Coun. Ernesto de Jesus and Coun. Eugenio F. Gregorio, Jr. duly seconded by Coun. Antonio Coronado be it resolve as it is hereby resolved that appropriate legal steps and action be taken for Titling of the above-mentioned area in the name of the Municipality of Antipolo, with any government agency charge with the issuance of said Title;

RESOLVED FURTHER, that to fully accomplish and realize the foregoing the amount of TWENTY THOUSAND (P20,000.00) be appropriated as it is hereby appropriated to be taken from any unappropriated amount of the General Fund or whatever source, for the expenses, to be incurred relative thereto, including legal fees and payments as may be needed or is necessary to the purpose above-stated and that is the Titling of the Market Area.

Resolved finally to support the undertaking by doing any or all acts for the final accomplishment of the purpose for which this resolution is made.

The motion was unanimously approved.
