WHEREAS, the Antipolo Municipal High School (AMHS) are occupying and renting two privately owned buildings located at P. Burgos St. and M. Santos St. owned by Mrs. Gloria M. Rolluqui and Mrs. Maria A. Reyes;

WHEREAS, the contract of lease between the Municipal Mayor of Antipolo and two owners mentioned hereof had expired last December 31, 1986;

WHEREAS, the building owned by Mrs. G. Rolluqui has eleven rooms while the building owned by Mrs. Reyes has 15 rooms;

NOW, THEREFORE, after due deliberation and on motion made by Coun. Celestino M. Gatlabayan duly seconded by Coun. Emilio B. Flores, be it resolve, as it is hereby resolved to renew the contract of lease of buildings aforementioned at P250.00 per classroom without any increase under the same terms and conditions in the previous contract of lease, inasmuch as the government has not yet provided school buildings or no available/vacant government edifice to house AMHS;

RESOLVED FURTHER that Mayor Felix B. Mariñas be authorized to enter into contracts of lease to both owners of the aforesaid buildings;

RESOLVED FINALLY, that copies of this resolution be furnished the Municipal Treasurer, other government authorities and parties concerned for their information and reference.
