Leyva, be it resolve as it is hereby resolve to purchase heavy equipment, office equipment, furnitures and fixtures enumerated hereunder with an estimated aggregate amount of NINE HUNDRED FORTY THREE THOUSAND FIVE HUNDRED (P943,500.00) PESOS to realize and remedy hereinabove objectives and premises;
